<p>This contract confirms <b>1</b> straw of <b>ANDIAMO SEMILLY</b> for <b>€300 Euros</b>  <b>without any live foal guarantee, taxes and shipment excluded.</b></p> <p><b>1 straw entitles 1 covering certificate, so a maximum of 1 foal born.</b></p> <p>If 1 straw gives more than 1 foal born, there will be additional costs of  <b>€300 euros plus taxes per each additional live foal derived from the use of this straw,</b>  immaterial of when, for whom and where it is achieved.</p> <p>The semen will be released when this contract will be signed, and the invoice paid.</p>		
<b>The purchaser confirms that:</b>		
<p>He is responsible for the straws bought under this contract :  number of straws : ..... / identification : .....</p> <p>He confirms that he has understood the terms of this agreement and commits to  <b>inform the seller if more than 1 foal is born derived from the use of 1 straw</b>  <b>before the declaration of the birth of the additional foal to any studbook</b>  <b>and pay to the seller the additional costs of €300euros plus taxes per each additional foal born.</b></p> <p>Any semen, purchased under this contract, will always remain under the terms of this contract for  its lifespan. The purchaser is fully liable, including in the case of resale and the new buyer  must be advised of this contract, agree with it and sign it.</p>		
<b>The seller and the purchaser confirm that:</b>		
<p>This agreement shall be governed by the laws of France with meaningful penalties in case of contract  defaults. Attempted fraud committed by the purchaser is punishable by an unconditional fine per non  declared additional foal of 3 times the price of Andiamo's covering fee in addition to a  penalty payment of 10% per year delay since the foal was born until the year the fraud is discovered.</p>
